




This chart shows the total general purpose revenue Literacy First Charter Schools expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Literacy First Charter Schools is \$35,030,564, of which \$25408236 is Local Control Funding Formula (LCFF), \$8289254 is other state funds, \$666593 is local funds, and \$666481 is federal funds. Of the \$25408236 in LCFF Funds, \$2737910 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Of that amount, \$3143581 is tied to actions/services in the LCAP and \$30,743,087 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:


Most of our general education, SPED, custodial, and recess salaries are not included in the LCAP nor are our property renovations, utilities, rents, or maintenance costs.


# **LCFF Budget Overview for Parents**

## **Goal Analysis**

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

This year, we focused a large amount of our training efforts in grades 3-12 on CAASP Interim Assessments. For grades K-2 we focused on trainings surrounding teaching reading in the classroom. We held at least two

trainings per month- once as a whole staff, as well as monthly by campuses. We were able to complete this goal and were successful in training our staff in the areas we deemed important this school year. The substantive differences in planned actions were that we did not send out any staff surveys this year. There was a substantive difference in planned actions over the three year cycle, with part 2B of this goal. As written, the goal is not attainable. We plan to re-write the goal for the next LCAP in a way that makes it measurable.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Budgeted expenditures were \$861,929. Estimated Actual Expenditures are \$1,117,206, a variance of 255,277. The variance is a result of under budgeting the costs of professional development and the travel costs associate with it, under budgeting our ELL Co-Ordinator's salary, and the budgeted amount for action 1.3 related to IEP's did not include the salaries ad benefits of a significant number of staff required to meet this goal / perform this action.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The majority of the actions listed were effective in making progress toward the goal during the three-year cycle. They were clear and written is such a way that meeting the goal was manageable. The last three metrics were the exception and will be re-written for the next LCAP.

LFCS was successful in rolling out interim assessments in grades 3-12, as well as benchmark assessments in all grade levels by the end of the year. This was our goal and we were successful in meeting the goal as written. The baseline for this metric as stated is not measurable. Looking ahead to our next three year LCAP, we will be rewriting this goal to assure it is measurable. Our students have improved each year on the CAASP according to our cohort data.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The Budgeted Expenses were \$223,909. The Estimated Actual Expenses are \$351,446, a variance of \$127,537. This variance is a result of increases to the cost of tech support, web based curriculum, computer software, and coaches.

## **Goal Analysis**

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We are thrilled with the parent participation this year, which this goal surrounds. Our parents were on campus daily, in higher numbers than we have seen since prior to COVID. They were helping in the classroom and around campus, they went on field trips, and participated in PTLC, DELAC and PLEF events.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The Budgeted Expenses were \$45,200. The Estimated Actual Expenses are \$108,526, a variance of \$63,326. We spent about \$20,000 more on parent engagement in 2023-24 than was originally budgeted as we launched a podcast series for parents , and a video series called, "Conversations with Parents" on topics such as nutrition, social media, and sleep cycles. The costs of translating were under budgeted by about \$40,000.

## **Goal Analysis**

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

This goal was successful in implementation. Our attendance rates improved, our students that showed the need for academic intervention were tested and offered services, and our staff and parents were trained through the year on areas we deemed important. There were no substantive differences in planned actions and actual implimitation.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The Budgeted Expenses were \$533,286. The Estimated Actual Expenditures are \$2,031,849, a variance of \$1,498,563. This variance is a result of significant underbudgeting for the salaries and benefits of staff to complete the actions of this goal, especially streamlining intervention services, providing support staff, and improving attendance.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

These actions came together nicely to support our student population and parents. We were truly able to assess student attendance since the pandemic, and we are starting to see a slight dip in the number of students being assessed for intervention services. These are all encouraging to see as we work to meet the goals we set in a post- pandemic world.
